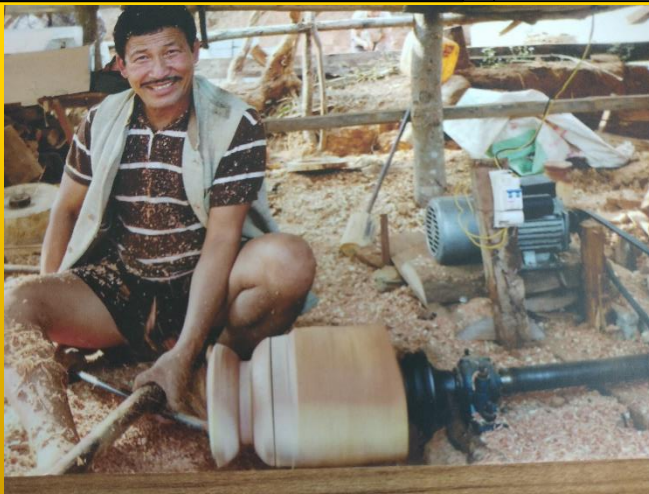

Executive Summary

SSICDC Gorkha had close to 200000 people who became its development partners at individual level benefitting community in health hygiene nutrition, entrepreneurship development, education, protection, livelihood and disaster management and response. The deadly earthquake of April 2015 affected the overall aspect of Gorkha and of Nepal as a whole. Being the epicentre of the deadly earthquake, Gorkha was among one of the most affected district of Nepal. With the help of national and international development partners SSICDC initiated the holistic approach of enhancing the life of people including their wellbeing in shelter, livelihood, DRR, wash, protection, education and strengthening protection mechanism.

In 2020 and 2021 we made our deliberate move towards focusing on the recovery and rehabilitation of the earthquake victims in consolidation with our national and international partners and donors. We made a strong hand agreement with our various donors Care Nepal, UNDP, Catholic Relief Services (CRS) for the rescue and recovery of the earthquake victims along with other donors like GOI supported Nepal Housing Reconstruction Project (NHRP) in Partnership with UNDP/ ODRC, UNDP/ CILRP, Lutheran World Relief (LWR) Raleigh International, UNICEF, WWF, PAF, JSDF, UNFPA, ICDF etc. Rescue and recovery operation was conducted with rapid initiation for life saving and to recover the suffering of the earthquake victims. Zero Tolerance Police, Child protection policy, gender policy, CFM Guideline, Code of Conduct and financial guideline were followed to the fullest for the accountability and transparency.

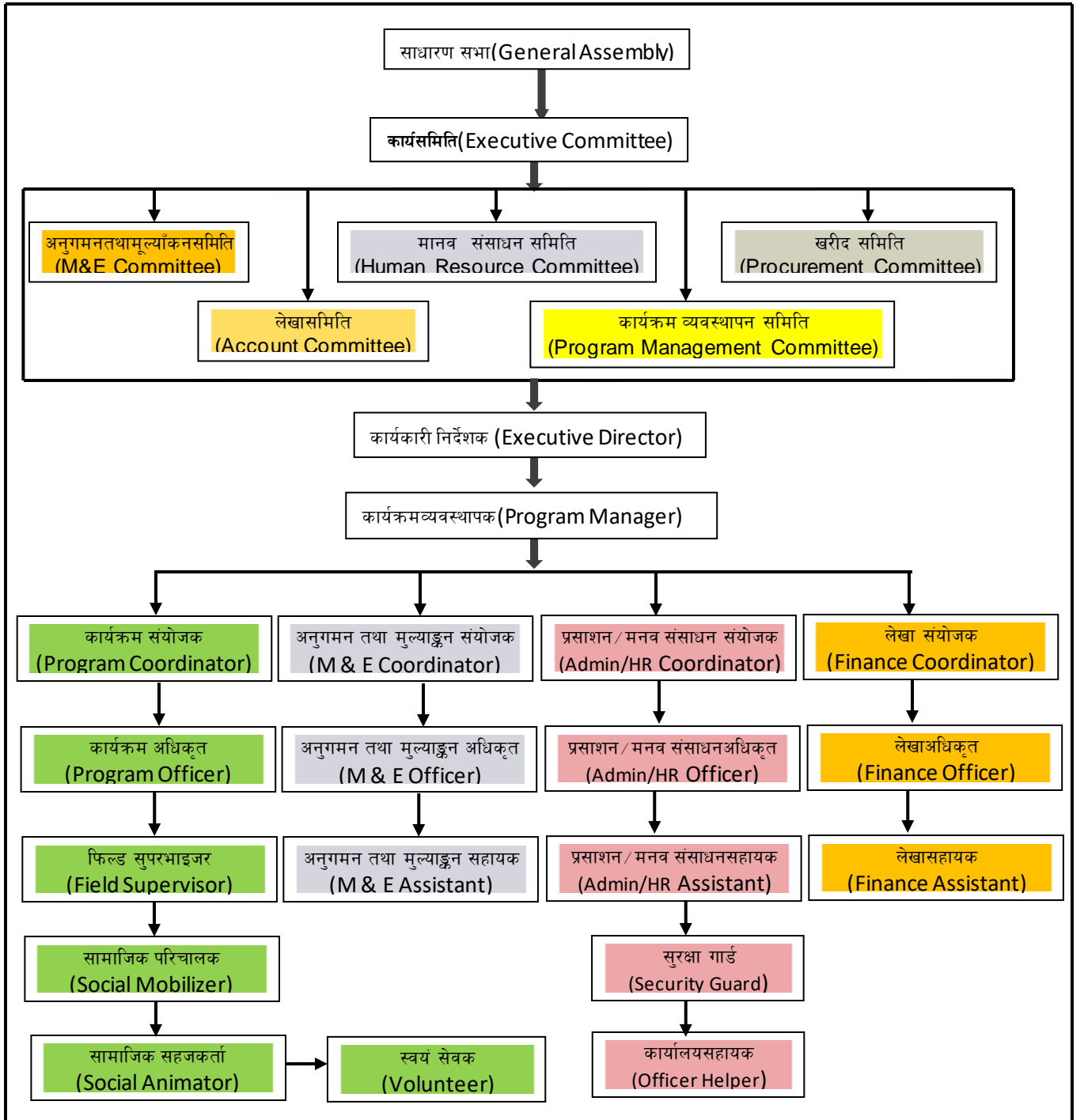

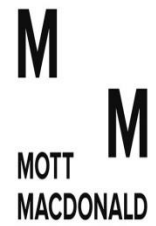

FOOD SECURITY AND LIVELIHOOD (FSL)

Every person has the right to a standard of living adequate for his or her health and wellbeing. This includes the right to food and livelihood protection. While it is accepted that food security and livelihoods-based approaches are complementary, it is important to recognize that they also have a high level of commonality. Projects were designed to promote agricultural production, provide irrigation and storage facilities and create enabling environment for activity of local markets, support micro-enterprise initiatives, capacity and skill building etc. In short, their goal was to improve a vulnerable community's access to sustainable sources of food and income.



The Nepal earthquake was devastating for local livelihoods. Some 2.8 million people were affected in total with livelihoods and sources of income destroyed, lost or disrupted. In this journey, SSICDC, Gorkha has collaborated with CARE Nepal through SUPPER (Sustainably Uplifting Poor Vulnerable and Socially Excluded Prosperity through Entrepreneurship Realization Project) and PRAYAS Project, Raleigh International, Lutheran World Relief, Catholic Relief Services and UNDP CILRP to promote food autonomy among the most vulnerable population groups, thus guaranteeing their food security and livelihood options in the short, medium and long term.

In this reporting period, following interventions were implemented in community with objective to improve the quality of life through raising earning capabilities of vulnerable HHs:

Community Based Disaster Risk Reduction (CBDRR):

As a country with diverse topography, complex geology and highly varying climate, Nepal is exposed to many natural and human-induced hazards. In a global comparison, Nepal ranks 4th in terms of climate risk according to the Global Climate Risk Index which assesses the impacts of meteorological events in relation to



economic losses and human fatalities. Also, the country ranks 11th in terms of global risk for earthquake occurrence and impact. The country is in top 20 of all the multi-hazard countries in the world.

Limited domestic economy, geographically dispersed, unconnected population, as well as diverse groups belonging to various castes contribute to the compounding social vulnerability to disasters. More than 80% of the population is exposed to the risk of natural hazards which include earthquakes, droughts, floods, landslides, extreme temperature, and glacier lake outburst floods (GLOFs). SSICDC Gorkha has adopted several mitigation and adaptation strategies and implemented various activities in this context in Gorkha through PRAYAS Project supported by CARE Nepal.

The project was implemented in close coordination with different organization at community, rural municipal and district.

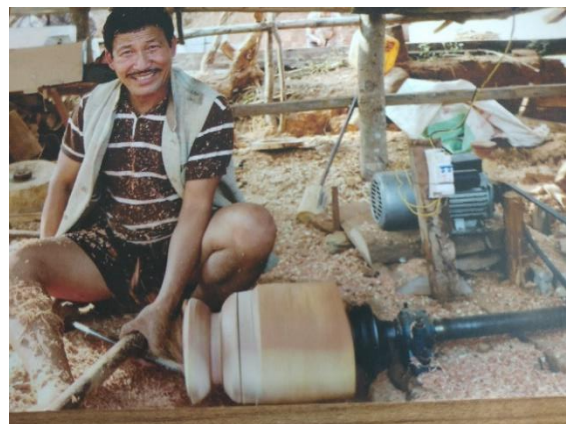

Now in Gorkha there is an increasing realization about the limitation of traditional model of business and also realize the importance of the enterprising ability of the young people for the continuity and sustainability of the enterprise so that we can achieve the income promotion, improve living standard and economic and social progress. SSICDC Gorkha support communities to established and start the youth lead various enterprise from the support with different funding partners and still continue support them to review business plan, marketing, challenge, opportunities, linkage with Local Government and documentation. SHELTER

Shree Swanra Integrated Community Development Centre (SSICDC) has given a vital importance to reconstruction of safer shelter in partnership with its international donors in line with the government guideline and policy after the devastating earthquake. We are working for capacity building through orientation, trainings and mass awareness activities on earthquake resistant safe shelter construction and financial and socio-technical support to households for the construction of permanent shelter in support of CARE Nepal, Save the Children, Lutheran World Relief (LWR), Catholic Relief Services (CRS) and UNDP/ODRC. The main aim is to support beneficiaries in recovery and reconstruction of their



shelter according to Government of Nepal reconstruction policies. Similarly all targeted beneficiaries enhanced their skills and knowledge in building back safer constructions through "on the job" training and mass awareness.

In this FY, SSICDC has implemented the three shelter related projects like, PRAYASS-II Project funded by CARE Nepal, Gorkha Recovery and Resilience Project Phase-II funded by CRS and Socio-Technical Facilitation Services to Support Nepal Housing Reconstruction Project funded by Government of India/UNDP/ODRC.

- 616 HHs were supported to link with building permit studios with the help of trained masons
- Supervision and certification was done to 159 HHs
- Design, planning and costing support was done to 558 HHs
- Total 9 Mobile Technical community campaign was conducted

Water Sanitation and Hygiene (WASH)

In April 2015, a 7.8 magnitude earthquake struck Gorkha District. It spurred more than 300 aftershocks. In May 2015 a second 7.3 magnitude earthquake struck. Over eight million of Nepal's 28 million people were affected with nearly 2.6 million in urgent need of emergency shelter, water, food, medicines, and reconstruction support of houses and medical facilities.

Having clean and safe drinking water and good sanitary environment is pivotal to promote healthy and quality life in community and for promotion of health and to change attitudes, it was necessary to educate. In support of different national and international organizations, SSICDC has been implementing WASH related activities, Drinking Water Supply and Sanitation Scheme construction, Hygiene Promotion, Water source protection, Water Safety Plan prepare and implementation, VHP,VMW and WSUC training and behavior change activities at different places of Gorkha districts. Following are the activities done by SSICDC in a year.

Gender and Protection

Gender equality and social inclusion is the major focus areas of SSICDC. It has always gave it a priority while implementing projects and also have lunched different activities specifically related to gender equality and social inclusions in community with the partnership of various funding partners and the communities.

Since most of the problems related to child or women violence are hidden in community itself and it was hard to get them surface by outsiders, so, coordination with different stakeholders were done including police representatives. With them, 3 coordination meetings were conducted to discuss about the ongoing issues at community and also regarding implementation process of project especially about score card use and their inclusion in community police partnership program. During this reporting period, 236 community justice resource people (CJRPS) were mobilized and conducted



1325 reflect sessions. In those sessions, 455 women, 435 men and 435 married couples participated. In those events, police, ward chairperson, judicial committee members also participated as a guest speaker. The guest facilitator provided the information on the planning process as the RMP and municipality are undergoing through their planning process. Reflect not only empowered the women and adolescent it also encouraged them to report the cases to the police and related stakeholders. In the same way it also enhances the participation of male for the protection of the women.

With objective to review plans developed in earlier quarter, total 54 review and reflection meetings were conducted. With participation of community people, ward representatives, FCHVs, officials, mother group members, priests and CJRPs, revision of last 6-month social change plan was done and prepare next 6 months plan.

During this report period, Social Norms Analysis Plot (SNAP) was conducted in 24 groups in working area of Gorkha. With target to empower adolescent, Rupantarn session followed by positive masculinity session was accomplished successfully in 6 schools of the project area mainly focusing on social norms, socialization, understanding gender roles, workload analysis etc. Among those sessions done in schools, 24 sessions were done with girls group and 24 sessions were conducted to boys group.

Under School Safety Projects (SSP), Workshop were conducted in all those 6 schools where teachers, SMC, PTA, representatives from education unit of RMP participated. Total 175 people participated. Along with that, monetary support to girls and boys groups were done to implement school safety projects (SSP). With this 6 SSPs were supported to implement which have encouraged adolescents to participate against GBV and spread awareness against it. Adolescents also visited health post and they were facilitated to interact with police which helped them to understand their role and responsibilities which eventually help them to seek support from them.

With consultation of community people, 6 sports activities were conducted in such a way that they could crack on the existing social norms related to women with objective to raise awareness to challenge the negative social norms existing in community. Altogether 315 male and 608 female involved.

Students were also taught about the complaint process after which code of conduct were revised with mutual discussion with teachers, students, SMC and PTA. They were facilitated for joint interaction on which 80 male and 63 female participated.

Along with all those activities, Rapid Gender Analysis (RGA) was done.

With all these activities, significant number women are taking the lead in various committee and activities at community and schools as well. Likewise, schools also have agreed to continue the Rupantarn sessions by mobilizing GBV focal person at school. Besides that, it has raise the trust between community people and police which has resulted in the increase of reporting of case to the police.

Climate Change and Bio Diversity Conservation

It is now widely recognized that climate change and biodiversity are interconnected. Biodiversity is affected by climate change, with negative consequences for human well-being, but biodiversity, through the ecosystem services it supports, also makes an important contribution to both climate-change mitigation and adaptation. Consequently, conserving and sustainably managing biodiversity is critical to addressing climate change.



With objective to reduce threats to biodiversity, improve livelihoods of the communities' people through enterprise development, SSICDC has implemented Hariyoban Program in support of CARE and WWF.

Beneficiary Feedback Mechanisms

SSICDC has a comprehensive **Beneficiary Feedback Mechanism (BFM)** to provide appropriate and accessible community-identified communication channels for targeted beneficiaries, especially marginalized groups, to share both sensitive and non-sensitive feedback on project activities. SSICDC put in place channels to receive and respond to

community feedback through the community-identified BFM, including two toll-free numbers (covering the two major national network providers) and face-to-face/community meetings through regular monitoring.

Project staff and the supporting MEAL team responded to non-sensitive feedback within 10 days, either through a phone call or in person, which closes the case. This response may consist of providing a needed explanation, responding to a concern/complaint or making a change as a result of the feedback. During the project period, a cumulative total of 44 feedback messages had been received and all of them are closed.





ANNEX VI: Our Stories

Hardships of not having house for elderly

Name: Musa Sunarni

Age: 78 years

Address: Sunwar Gaun, Tandrang

Musa Surnarni, a single elderly lady is a permanent resident of Vimsen Thapa -2, Tandrang. She lost her husband many years ago. Though, she has 3 daughters and a son but all are living separately with their own family. Even before earthquake, she used to live alone completely depending on old age payment. At that time, she at least had a house to live.



She said, earthquake took my only one property I had. Since then, I was roaming around living with different relatives. She is a victim of earthquake and got 1st tranche as well but all of the money was spent on medical and other daily expenses. When, SSICDC in support of CRS started vulnerable house support, she was selected as one of the beneficiaries to be supported but she could not be found anywhere near the community. After multiple interactions with community and search of her possible whereabouts, it was found that she was in Damauli with one of her daughter. When she came back, SSICDC team discussed about the support, SSICDC going to provide and also her plan about the house construction in presence of ward members and few community people but she did not want to start construction. She told, that there is no one to support her to build house and she can not do it herself. Then, a cluster meeting was conducted with the hope of getting support from community and local authority. During that meeting, a member of Tole Sudhar Samiti took whole responsibility to complete her house with a clause that SSICDC will provide technical and MLT support.

After that, her house was started and SSICDC provided her CGI sheets, door, windows and 5 man days unskilled labor. Now, her house is complete and she is living in that house. Now, though, she is alone but she has a secured, earthquake resilient house to live.

The Story of Buddhey Kami's House Reconstruction by Ganesh Dhakal

My name is Ganesh Dhakal and I was recruited as a social mobilizer for PRAYAAS-II project on August 2018 in the 'Shree Swara Shagan Integrated Community Development Center'. In the initial phase of the project, we were informed to verify the beneficiary list of NRA for reconstruction and livelihood support of vulnerable households. In this course, I went to Buddhey Kami cottage. I saw his tented house and his 65 years old wife watering the vegetables. I greeted both of them. Misses Kami brought a mat for me to sit. After that, I started a conversation with the old couple.



I, first, asked why you still did not construct your house. He instantly replies, "My name is not listed in the earthquake beneficiary list. Even if the name came, this land is registered in the name of my daughter-in-law." I received many answers in my single question. I immediately ran to ward office and requested Engineer of National Reconstruction Authority (NRA) to provide the earthquake-affected beneficiary list. I thoroughly checked the list and found the name of Buddhey Kami and noted the number of the blue card. Without taking much time, I, again, went to Buddhey Kami's house. They were amazed to see me again and questioned, "Are you staying here tonight?". I reply, "Yes."



After some time, I asked them whether you have a blue card. He answers, "No". I, again, asked him to bring all the documents he had. He carried three tin boxes and says all the documents are placed in here. He unlocked the box and took out all the documents. *"I am not literate either my wife. Three years back, authorities from the different organization used to visit us every day and asked many questions, I answered them what they had asked and gave me documents. I never query who are they and for what purpose*

they are collecting information." –says Buddhey Kami.

I searched all his documents and finally, I found that blue card which was placed inside the OPD card. The card number "1504090" matched with the number I collected from the ward. I, now, felt relaxed and happy.

When I informed Buddhey Kami that his name is already enlisted in the earthquake-affected beneficiary list, he did not seem happy that much. *"This land, where we are living is in the name of my daughter-in-law and I am afraid whether she will allow for house reconstruction."* I met with her daughter-in-law, Chini Maya B.K', after the general conversation with her, she says, "My husband died while he was in overseas. I am the only one who will look after them. I won't object if they reconstruct their house"

On 2nd October 2018, Budhey Kami, his daughter-in-law- and I went ward office for the house reconstruction agreement and did agreement. After that, I regularly visit his house for follow-up and he often asked, "Son!!! When we will receive our first installment? My wife and I are weak, isn't it possible for you to bring the amount of that first installment"

"Waiting for the day with complete happiness"

Kerabari-1, Siranchowk Rural Municipality: "I, now, can write my name and read it. For an illiterate woman like me, this is the biggest achievement." - Man Maya Kunwar expresses her happiness. 54 years old Man Maya Kunwar is living with her husband. Her elder daughter stays at Beshisahar, Lamjung and her younger daughter is married. When she was questioned, how did she learn to read and write her name, she gracefully replies, **"I attend the REFLECT class which runs nearby my house. REFLECT Miss taught me how to write the name and read."**

Man Maya is among those villagers, who haven't constructed her house. With her husband, she is living in a partially damaged house. Her house is cracked from all side, making quite insecure to live. In a painful voice, she tells, "In the monsoon, rainwater enters through the cracked hole and cold air in the winter."

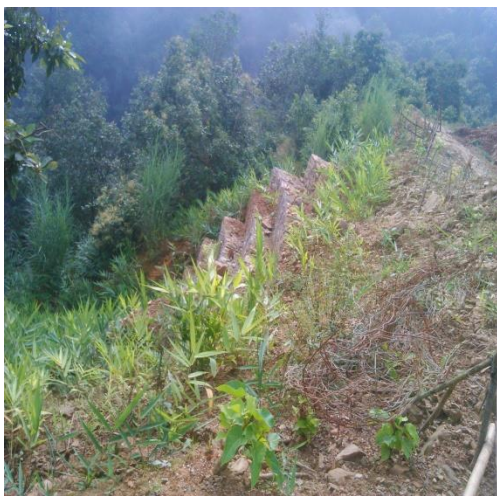
Struggling with all these hardships through her life, she, now, has a reason to smile, because she knows how to write her name and read it. This attempt by her make brings a beautiful smile in her face, but she still feels her happiness is not complete yet. She tells us that, **"I don't have a citizenship card. Last year, many women in her village made citizenship card through mobile camp deployed by District Administration Office, Gorkha. I, every day, requested my husband to make my citizenship card during that time, but it was like talking to a wall. He neither said 'yes' nor 'no'."**

When she shared her problem in the REFLECT class, members from REFLECT come to her home, and tried to convince her husband, he said not and chased them away. After that, he also yells at her for humiliating him in front of others.

"In this long journey of my life, grief never left me, and happiness never accompanied my journey. I never wished for bigger than life. I just want citizenship card of mine. Prior to REFLECT class, I just wanted to make citizenship because most of the women of villages have a card. When I attended the REFLECT class, REFLECT 'Miss'learned that how I will be deprived of government facilities." - she adds, **"I hope my husband will agree to make a citizenship card one day. I am waiting for that one day of complete happiness of my life."**
